

AMENDED ARTICLES OF INCORPORATION OF THE VISAYAN SURETY & INSURANCE CORPORATE

KNOW ALL MEN BY THESE PRESENTS:

ACCORD AS THE

That we, a majority of whom are residents of the Philippine Islands, have this voluntarily associated ourselves together for the purpose of forming a corporation under laws of the Philippine Islands.

And we hereby certify:

First.- That the name of said corporation shall be "VISAYAN SURETY & INSURANCE CORPORATION". (as amended).

Second.- That the purpose for which such corporation is formed are to save any person or persons or other entity harmless from any loss, damage or liability arising from any unknown or future or contingent event; to indemnify or compensate any person or persons or other entity for any such loss, damage or liability, and to guarantee the fidelity of persons holding public trusts and to execute and guarantee bonds and undertakings in judicial proceedings and to agree to the faithful performance of any contract or undertaking made with any public authority (as amended).

To act as agent for insurance companies of every class and to conduct a general insurance agency and insurance brokerage business.

This corporation shall possess and enjoy all the powers, privileges and franchises granted to, and shall be subject to all regulations, restriction and obligations imposed upon insurance corporation under the provisions of Act No. 1459 of the Philippine Commission and any amendments thereto and Act No. 2427 of the Philippine Legislature and any amendments thereto.

Third.- That the place where the principal office of the corporation is to be established or located is Cebu, Philippine Island.

Fourth.- That the term for which said corporation exist is FIFTY (50) YEARS from and after the date of incorporation which is hereby extended for another FIFTY (50) YEARS from and after JULY 14, 1981, the expiry date of the original term. (-amended) of \(\sqrt{e}y \) 3, 1981)
